Subject :- Submission of Life Certificate

As per extant procedure, pensioners/family pensioners are required to appear in person at Treasury Offices in November every year for continuity of pension/family pension. In order to simplify the process of securing Life Certificate and for the welfare of the old aged/infirm persons, the Prime Minister, Shri Narendra Modi launched "Jeevan Pramaan"- an "Aadhar-based Digital Life Certificate". for pensions that will push towards self-certification which will do away with the requirement of a pensioner having to submit a physical Life Certificate in November each year.

Due to Covid-19 pandemic, pensioners/family pensioners are hereby given option to submit Life Certificate for current year either in existing normal system or in digital format through nearby Citizen Common Service Centres as per their own convenience.

Further, as per request of the Mizoram Civil Pensioners Association (MCPA), pensioners/family pensioners are hereby allowed to submit Life Certificate for current year duly countersigned by authorities as contained in Rule 343 of CTR VOL-I through the respective Branch of MCPA which will, after due scrutiny, further submit to the Treasury Offices.
