- (g) Tualchhung thuneitu emaw State Sorkarin emaw Forest huamchhunga ram chu *patta* turin emaw hawh turin emaw pek turin a tih dawnah pawh chanvo/dikna an nei a ni;
- (h) Forest chhunga khua leh chenna hmun reng reng, khua la theh fel loh leh khaw dangte pawh, chhinchhiaha hriattirna siam tawh an ni emaw ni lo emaw chhiah lakna tur khua siam tur leh benbel tur chungchangah chanvo an nei a ni;
- (i) Forest hausakna an intunnun nana an lo humhalh leh vawnthat thin te humhalh a, cheitha a, vawngtha tur leh enkawl zui turin chanvo an nei a ni;
- (j) Eng State-ah pawh Tribal-te chanvo anga chung hnam bikin dan anga an lo neihsa emaw State Sorkar danin emaw Autonomous District Council-in emaw Autonomous Regional Council-in emaw an chanvo anga a puan te chu an chanvo a ni zel ang;
- (k) Thil nung chi hrang hrang leh khawtlang huap chanvo atanga tunlai thiamna leh pi pute atanga finna thil nung chi hrang hrang leh hnam nunphung hrang hrangte nena inlaichinna nei zawng zawngte chhawr theihna chanvo an nei;

- (l) Forest a cheng thin Scheduled Tribe leh Forest-a cheng kumhlun dang te'n an chanvo kumkhuaa an lo neih thin, clause (a) to (k)-a sawi lan lohte pawh an chanvo a ni zel ang a, mahse hei hian sapelte, thangkamte, ramsa eng pawh an taksa bung hrang engpawh lakchhuah theihna chanvo a keng tel lovang;

4. (1) A hun laia dan dang hman mek eng pawhin engtiang pawhin lo sawi pawh nisela, he Danin a phalsak ang chinah chuan, Sorkar laipui chuan hengte tan hian Forest chungchanga an chanvo a hriatpuin a pe a –
- (a) Section 3-a Forest chungchanga chanvo a sawi zawng zawnge State chhunga Scheduled Tribe Forest a chengte emaw State chhunga awm Scheduled Tribe-a puante;
- (b) Section 3-a Forest chungchanga chanvo a sawi zawng zawnge Forest a cheng kumhlun dangte;
- (2) He Danin Forest chungchanga chanvo a pekte hi nungchate chenna pawimawh bik National Park leh Sanctuary hmuna awmte tan chuan tihdanglam emaw siamthat emaw a tul mai thei a, amaherawhchu chutianga chanvo neitute a hnuia sawi anga thil a thlen chauhvin anmahni chu an awmna ata sawnchhuah emaw nungchate humhalh nan an chanvo nghawng thei tura thiltih theih a ni ang: -
- (a) Chutianga tih tulna hmuna mite tan chuan section 6-naa an chanvo hriatpui leh pek dan sawite hi zawm famkim tur a ni.
- (b) State Sorkar-in a ngaihtuahtu tura a ruat bikten Wildlife (Protection) Act, 1972 thuneihna hmanga chutiang chanvo neitute chu sawn chhuah emaw an awmdan tihdanglam ngai ngei nia an ngaih chauhvin;
- (c) State Sorkar-in ruahmanna dang, entir nan, insuan chhuak kher lova awm hi dan emaw kawng dang awm theia an hriat lohvin;
- (d) Sorkar laipui dan siam leh duh dan anga sawnchhuah ngai mimal leh khawtlang tan mitin khawsakna tur tha tawk ruahman sak an nih thu hriattira sawn chhuah theih an nih chauhvin;
- (e) Anmahni sawn chhuahna tur ram chunga thuneitu *Gram Sabha* te'n a ram chungchangah leh ruahmanna siam chu ziaka remtihna an pek chauhvin;
- (f) Sawnchhuah dan tur ruahmanna siam anga an mamawh tur engkim leh ram an chan tur theuh bitlhiah fel hma chuan sawn chhuah an ni lovang;
- A chunga sawi nungcha pawimawh bakte chenna hmun chuta tanga chanvo neitute pawh sawnchhuah an nihna hmun hi a hnuah State Sorkar emaw sorkar laipui emaw thuneitu dang pawhin thil dang atan an hmang leh thei tawh lovang;
- (3) He Dan hmanga Forest a cheng thin Scheduled Tribe-te leh Forest a cheng kumhlun dangte hnena an chanvo hriatpui leh pek chungchangah, eng State emaw Union Territory nen pawh forest awmna ram leh a chhunga chengte chungchangah chuan chung Scheduled Tribe te emaw Tribal dang emaw Forest a lo cheng kumhlunte chuan forest awmna ram chu December 13, 2005 hmalamah an lo luah tawh a nih chauhvin hriatpui leh pek theih a ni ang;

- (4) Sub-section (1) anga chanvo pek chu inrochun theih a ni ang a, mahse midang hnena hrall chhawn emaw hlan chawn emaw theih a ni lovang a; nupui/pasal neite chu an nupaa hmingin a intawma register tur a ni ang a, chhungkuua lu ber nupui/pasal neilo a nih chuan ama mimal hminga register tur a ni ang a, roluah tu tur chiangsa a neilo a nih chuan roluah tu nihna chanvo chu an laina hnai ber hnenah pek a ni ang;
- (5) Danin a phal ang a nih loh chuan Forest a cheng Scheduled Tribe emaw forest-a cheng kumhlun thin midangte chu an chanvo tur hriatpuina leh enfiahna hna zawk a nih hma chuan forest hmung ram an luah lai atanga umchhuah emaw dahsawn emaw phal a ni lovang;
- (6) Sub-section (1) sawi anga ram Section 3 sub-section (1) clause (a) a sawi chungchangah leh Forest chungchangah chanvo hriatpuina leh pekna thuah, chutiang ram chu mimal emaw chhungkuua emaw khawtlangin emaw he Dan hman tan a nih hian an lo luah tawh tur a ni a; an ram luah chin chiah atan pek tur a ni a, chu chu hectare li (4) aia zau a ni tur a ni lo;
- (7) He Danin a sawi anga phalsak a nih loh chuan, ram ngaw chungchangah chanvo pek hi sawibuai theih leh thil dang chawi ngai leh sawi ngai, Forest (Conservation) Act, 1980 sawi anga ‘net present value’ leh compensatory afforestation te pawh huam telin, heng zawng zawng hi a thlawna tihsak tur an ni.
- (8) He Dan hmanga Forest chungchangah an chanvo hriatpuina leh pekte chuan Scheduled Tribe leh hnam dang Forest a cheng kumhlun thinte, an chenna leh an lo neihna hmung atanga State hmasawnna tura hmalakna avanga sawn chhuah, mahse zangnadawmna tura ram pek leh chuan si loh an ni tih finfiahna nei theite pawh a huam ang a, an ram chu laksak an nih atanga kum nga hnuah pawh an laksak chhan angin hman a ni leh si lo tih finfiah bawk tur a ni.

5. Forest chungchangah chanvo pe theitu Gram Sabha emaw he Dan hman Forest chungchangah chanvo an ram huam chhunga pe theitu khaw khata thuneitute chu heng ti tur hian thuneihna pek an ni: -

- (a) Ramsate, ngawte, thilnung chi hrang hrangte venghim turin;
- (b) A chhehvel ramte, lui leh dilte, nungcha leh thlaite inmamawh tawnna vawng him zel tura hmung pawimawh bikte tha tawka venghim turin;
- (c) Forest-a cheng thin Scheduled Tribe-te leh forest-a cheng kumhlun dangte tichhia a an hnam nunphung leh tihdante tichhe theitu laka vawng him turin;
- (d) Gram Sabha-in vantlang Forest hausakna hman dan tura a thurel chu ramsa, forest leh thilnung chi hrang hrang tana pawi lo tur zawnga zawm ngei a nih theih nana hma la turin.

BUNG IV - NA

FOREST CHUNGCHANGA CHANVO PEK DAN LEH THUNEITUTE

- (9) 6 (1) Mimal emaw khawtlang huap emaw a pahnhin emawa Forest-a cheng thin Scheduled Tribe leh Forest-a cheng kumhlun dangte he Dan hmanga an thuneihna huam chhunga awmte hnena chanvo pek dan tur chin leh a nihphung chungchanga hma la tantu tur chu Gram Sabha a ni ang a, chanvo tur hauhna (claim) te a dawng ang a, la khawmin a enfiah ang a, chutiang chanvo pek dan tura ruahmanna siamsa angin a ram zau zawng tur chin chhinchhiahna *map* a siam ang a, Gram Sabha chuan thuthlukna (resolution) siamin a copy chu Sub-Divisional Level Committee hnenah a thehlut ang.
