NOTIFICATION

It has come to the notice of the Government that several Government Departments / Agencies have submitted proposals for purchase of Light Motor Vehicles (LMVs) in relaxation of 'The Government of Mizoram Vehicle Outsourcing Policy, 2019' simply on account of the fact that Departments have received State/Central fund at their disposal for purchase of the vehicles.

All Government Departments / Agencies are hereby reminded that the Policy was introduced as per the approval of the Council of Ministers in its meeting held on 8.11.2019 as part of economy measures in order to limit expenditure on purchase and maintenance of vehicles and recruitment of drivers. Purchase of vehicles (LMVs) and recruitment of drivers are banned for all Government Departments / Agencies under this Policy except for certain Officers / Offices as specified vide Notification No.D.26017/16/2019-GAD dt.19.11.2019. The Policy is also applicable for any provisions made under Centrally Sponsored Schemes / Central Sector Scheme / Externally Funded Projects.

Therefore, strict compliance and adherence to 'The Government of Mizoram Vehicle Outsourcing Policy' is requested of all Government Departments / Agencies as it has become operational and frivolous proposals for purchase of LMVs will not be entertained henceforth.


